Affordable Housing Now

THE PROBLEM: A shortage of affordable housing for low & moderate-income families and individuals.

- ▲ Many New Mexicans live in substandard and/or aging homes that need rehabilitation.
- ▲ There is a lack of new construction that low and moderate-income people can afford to rent or buy.
- ▲ Our population is increasing about 2% a year.
- ▲ Each night approximately 13,000 people are homeless in our state.
- ▲ Our communities need increased capacity to develop affordable housing.
- ▲ The elderly, farm workers and Native Americans have particular housing challenges.
- ▲ Many thousands of New Mexicans live in colonias, which lack critical infrastructure: roads, water, sewer, and power.
- ▲ In New Mexico, a full-time worker must earn \$11.14/hour in order to afford a 2-bedroom rental unit (\$8.91/hour for a 1 bedroom) at the Fair Market rent of \$579 a month. A worker earning the minimum wage must work 87 hours per week in order to afford this 2-bedroom unit.

THE SOLUTION: A state housing trust fund would benefit all New Mexicans.

- ▲ Increase availability of affordable housing for low-income families.
- ▲ Expand state and local tax bases.
- ▲ Build a stable, adequately housed, workforce that attracts further economic development.
- ▲ Enhance economic development through job creation, increased construction, and spin off industries and investments.

A state housing trust fund provides a flexible funding source to meet New Mexico's housing needs by providing dedicated funding that can be targeted for projects to meet community needs, and that can be leveraged to bring additional public and private resources into affordable housing initiatives.

- ▲ It is estimated that \$10 million per year would allow the trust fund to begin working effectively.
- ▲ Funds from the trust fund could be used to target community-identified affordable housing needs.
- ▲ Funds from the trust could be used to leverage federal and private housing resources greatly increasing the total funds available in New Mexico for affordable housing.
- ▲ Potential sources of funding include severance tax bonding funds, portion of unclaimed property, reversion or escheat, private activity bonds (per unit surcharge), estate taxes, and general fund appropriations. Other sources have been identified and utilized in other communities nationwide.

New Mexico Housing Trust Fund Coalition is a coalition working together to find solutions to New Mexico's affordable housing crisis.

Our organization endorses the proposal by the New Mexico Housing Trust Fund Coalition to create an Affordable Housing Trust Fund providing at least \$10 million annually from a dedicated source to create and preserve affordable housing to meet the needs of low and moderate-income New Mexicans.
